4. Treasurers Report

Special Motion as advised to members to amend the club rules for the financial year to 31/3 annually to facilitate allowing annual meeting to be conducted straight after end of season

Motion to set the annual club membership at \$5 per adult member Moved P Willcox

Senior cricket cash inflows for the year were \$44,253.08 (previous year \$49,101.50) and outflows \$55,380.98 (previous year \$51,711.11) leaving a closing bank balance at end of period of \$2,200.61. Reduced income across the board from sponsorship, events and canteen sales along with additional expenses with coaching, curating/ground maintenance as well as new turf wicket on Martin Park 1 have seen funds on hand drop to current level. Some of this has already been addressed with some existing and new sponsors renewing their commitments, playing fees/levies will need to be reviewed, social activities increased and canteen sales looked at. Expenses should be at similar levels this season with the only major capital commitment being the replacement of the cricket training nets with a cash component of \$5000 and in kind labour and inputs of \$25,000. Junior committee has managed to make a small profit of \$107.83 for the season, leaving a bank balance of \$10,889.93 to continue supporting the clubs cricket activities. They have a planning meeting next week to start work on next season and are working on replacing sponsors that have dropped off from the last 3 year program Moved C Borrell Seconded Joel O'Connell Passed
